



Privacy Policy

Medical Wellness Clinics, Inc. ("Medical Wellness") provides you with this privacy policy ("Privacy Policy") to let you know Medical Wellness' information collection and usage policies and practices that apply to information collected on this website (the "Site"). By using the Site, you agree to the terms of this Privacy Policy and agree to be bound by the Site's Terms of Use. If you do not agree with this Privacy Policy or the Terms of Use, you are not allowed to use the Site, and must discontinue your use of the Site immediately.

Information Collection

When you visit the Site, Medical Wellness, through its technology provider, Primary Web, ("Primary Web"), collects information about you and your browsing habits. The information we collect depends on the pages of our website you visit and what you do during your visit. When you provide information on the Site, Primary Web receives and processes it on our behalf. Primary Web will collect, use, and share your information in a manner that is consistent with this Privacy Policy, which means that Primary Web, in connection with its own business, will have all the rights with respect to your information that Medical Wellness does, but only to the extent necessary for Primary Web and Medical Wellness to fulfill their respective contractual obligations to one another.

Medical Wellness may collect information from you automatically when you visit our website, which may include the name of the domain and host from which you access the Internet; the Internet protocol (IP) address of your computer; the type of browser and software operating system you use; web log data, including the date and time you access our website; and the Internet address of the website from which you linked to our site. Several companies offer tools that allow people to browse the web anonymously. We cannot provide you a personalized experience if you use these tools, because we cannot recognize you and your computer. However, we want to ensure you know of their existence.

Because Medical Wellness does not track your online activities over time and across third party websites in order to provide targeted advertising, Medical Wellness does not respond to Do Not Track (DNT) signals. Medical Wellness may also use cookies to enhance browsing on our website. "Cookies" are small files or records that are placed on your computer's hard drive to collect information about your activities on our website. You can choose to have your browser

warn you every time a cookie is being sent to you, and you can turn off cookie placement. If you refuse, your overall browsing experience can be affected and may prevent you from fully using the Site.

Medical Wellness may also use "message format" and "message open" sensing technologies to enable Medical Wellness to recognize whether you have enabled your email program to receive HTML emails. If so, this information is associated with your email address so that we can send subsequent messages to you in HTML format. The "message open" sensing technology allows us to recognize whether you have opened our email messages. We can only detect this if you have enabled your email program to receive HTML emails.

For most of the browsing services on the Site, Medical Wellness does not require your personal information. There are portions of the Site where you will be given the option to provide information about you. The information that you may be asked to provide may include your name, email address, telephone number, and address. Depending on your request and other circumstances, other information may also be collected. It is your discretion and determination whether to provide such information.

Use of the Information

Medical Wellness uses the information it collects (whether submitted by you or automatically collected) to respond to your requests, to provide you with information that Medical Wellness thinks may be of interest to you, and to operate its business. Medical Wellness may also disclose your information to its affiliates, agents, and third-party vendors and service providers working on our behalf. Medical Wellness has implemented technical measures to protect against the risks of unauthorized access to, erroneous disclosure of, and unlawful interception of Personally Identifiable Information.

You should know, however, that Medical Wellness cannot fully eliminate such risks. In addition, Medical Wellness may disclose aggregated data and statistics in order to describe the Site to prospective partners, advertisers, and other third parties, to improve and market its products and services, and for other lawful purposes. Additionally, Medical Wellness may disclose part or all of a user's personal information when Medical Wellness believes, in good faith, that the law requires or compels such disclosure, or when Medical Wellness has good faith reason to believe that disclosure is necessary to protect Medical Wellness' rights or property, the rights of another user, or to prevent harm.

Further, Medical Wellness may disclose information provided by you as part of any merger, sale, acquisition, or other acquisition of some or all of Medical Wellness or its assets. Medical Wellness may choose to buy or sell assets or may transfer the Site, or permit someone else to operate or otherwise take responsibility for the Site or a successor version thereof. Medical Wellness may share and/or transfer your information in connection with the evaluation of and entry into such transactions.

Also, if Medical Wellness (or its assets) are acquired, or if Medical Wellness goes out of business, enters bankruptcy, or goes through some other change of control, your personal information could be one of the assets transferred to or acquired by a third party. Medical

Wellness reserves the right to access, read, preserve, and disclose any information that it believes is necessary to comply with the law or a court order or protect the rights, property, or safety of our company, our employees, our users, or others.
